#1E-2026-0202: RESOLUTION ESTABLISHING A SPECIAL COMMITTEE ON GEORGIA AVENUE ECONOMIC DEVELOPMENT

WHEREAS, Advisory Neighborhood Commission 1E is charged with representing the interests of residents and businesses within its boundaries; and

WHEREAS, the Georgia Avenue corridor within ANC 1E has experienced persistent commercial vacancies, limited foot traffic, and underutilization relative to comparable commercial corridors in the District of Columbia; and

WHEREAS, strategic corridor revitalization requires coordination among residents, business owners, property owners, District agencies, and other stakeholders; and

WHEREAS, Article [Committees section] of the ANC 1E Bylaws authorizes the Commission to establish Special Committees to address specific objectives;

NOW, THEREFORE, BE IT RESOLVED that ANC 1E hereby establishes a Special Committee on Georgia Avenue Economic Development (“the Committee”) for the following purpose:

Section 1. Purpose

The Committee shall:

- Study economic conditions, commercial vacancy trends, pedestrian activity, and business needs along the Georgia Avenue corridor within ANC 1E.
- Identify evidence-based strategies to:
 - Reduce commercial vacancies
 - Increase foot traffic and evening activity
 - Support small business stability and growth
- Develop policy and budget recommendations for consideration by the full Commission.
- Engage with corridor stakeholders including residents, business owners, property owners, and relevant District agencies.

The Committee shall be advisory only and shall make recommendations to the full Commission for approval.

Section 2: Membership

- The Committee Chair (or Co-Chairs) shall be appointed by majority vote of the Commission and must be a resident of ANC 1E.
- The Committee Chair(s) shall determine the composition of the Committee, subject to modification by majority vote of the Commission.

- Non-resident business owners and other stakeholders may participate as advisory participants. Formal committee membership shall comply with ANC 1E residency requirements.

Section 3: Duration

This Special Committee shall dissolve one year from adoption of this Resolution unless renewed by majority vote of the Commission.
